The social parties constituting the National Employment Council for the Agricultural Industry in Zimbabwe (NECAIZ), which are the Zimbabwe Agricultural Employers Organisation (ZAEO), Zimbabwe Commercial Farmers Union (ZCFU), Zimbabwe Farmers Union (ZFU), Commercial Farmers Union (CFU) and Horticulture Employers' representatives on the employers' side and the General Agriculture and Plantation Workers' Union of Zimbabwe (GAPWUZ) and Horticulture, General Agriculture and Plantation Workers' Union of Zimbabwe (HGAPWUZ), Agriculture and Allied Workers Union (AAWU), Progressive Agriculture and Allied Industries Workers Union of Zimbabwe (PAAWUZ), Zimbabwe Horticulture Agro Industries and General Agriculture Workers Union (ZHAGAWU) representatives on the employees' side, have agreed on the following provisions concerning minimum wages in the Horticulture subsector effective 1 May 2025.

- The minimum wage for the Horticulture subsector shall be increased from USD94.00 to USD99.00
 payable in a component of 80% United States Dollars (USD) and a USD component of 20% convertible
 to the Zimbabwe Gold (ZWG) currency according to the prevailing interbank rate on the date of
 payment. Entities with capacity can pay 100% in USD dollars.
- 2. Schedule A below provides the minimum monthly wages for the Horticulture subsector. The minimum wages provided in the schedule are effective 1 May 2025.
- 3. Notwithstanding anything contained in any collective bargaining agreement applying to the generality of the agricultural industry, and without derogation from any further allowances provided for in any such collective bargaining agreements, the Horticulture subsector has agreed to the minimum allowances referred to in Schedule B below, and these shall be binding on all employers and employees in the Horticulture subsector.
